NOTES FROM THE WYNLAKES HOA

- *Trash Cans*: Since all our subtle hints have been ignored, we will step up the game plan. Green or pink trash cans CANNOT be visible from the street or any adjoining property other than Tuesday and Friday (pick up days). This is covered in Article. 7.17 of the Covenants. An expensive home with an overflowing garbage can against it loses some of its appeal and contributes nothing good to the landscape or property value. Please be a good neighbor and help keep Wynlakes property values high.
- *Basketball Goals*: It has been brought to our attention that basketball goals are growing more and more common in our community and are being installed without regard to the rule. The rule states: If you have a basketball goal, it should be portable and should be out of sight when not being used. Permanent goals must be approved by the Modification Committee; so if you have one, you should have an approved modification form in your folder. We will begin to write warning letters to property owners to ensure that they are aware of the rule and abide by it.

INVOICES

• Invoices for the January-July 2017 dues were mailed in December. Remember, you have the entire month of January to pay dues. Payments not received by January 31 will have a service charge added to their account. If not paid at that time, we send out a "Did you forget us" letter. On the 15 of February, if still not paid, we remind you if payment is not received by the end of February, the account will be forwarded to our collection agency. On the first work day in March, the delinquent accounts are sent to our attorney who adds a \$275 fee plus all other legal fees to obtain a judgment.

INCREASE: The increase in dues is effective 1 Jan 2017. Homeowners paying \$390 will pay \$414; those paying \$450 will pay \$458.
