**Parking.** Owner of a Unit shall provide space for the parking of at least three (3) automobiles, unless modified by the Design Review Board, per dwelling unit off public streets. Parking must be confined to the interior of the Unit and not on public right of way.

#### **MODIFICATION INFORMATION**

The Modification Committee **MUST** approve/disapprove **ALL** changes to the exterior of the unit and any landscaping. If you replace in kind (example: paint the same color, replace the roof with same color and kind, replace rotting wood, fix broken concrete) you do not need a modification form. However, if you receive a letter asking what you are doing, PLEASE RESPOND. The next letter will tell you to cease and desist and give you instructions to meet with the Covenants Committee for failure to comply with modification procedures.

When you closed on your house, we sent a letter advising you of the rules governing Wynlakes and the modification rule is highlighted. When you moved in, we sent a newcomer's package with the rule highlighted and a copy of the form needed. When we notice activity at your unit, we send a letter requesting information along with a copy of the modification form. In each newsletter we print the information. We make every attempt to make sure you are aware of the need to obtain permission to modify your property before you initiate the process. If there is any doubt, please call the office and we will be glad to help answer any questions.

## **REMINDERS**

All exterior work on a house or in the yard must be approved before work begins. Please allow at least two weeks from time of submission of your modification request to the projected start date for work to begin.
