Recently it was brought to our attention that many residents allow their pets to go on the vacant lots around the area as well as the lawns and sidewalks. We are asking you not to practice this behavior as the odor is offensive to the surrounding homes and no one wants to clean up after someone else's pet. Let's all be good neighbors and respect the property of others.



PARKING:

Does your neighbor park his or a guest's car on the street overnight? We receive calls at the HOA about cars parked overnight on a regular basis. We know it can be an inconvenience to move cars around in the driveway early in the morning or late at night; however, Covenant number 7.29 states: <u>Parking</u>. Owner of a Unit shall provide space for the parking of at least three (3) automobiles, unless modified by the Design Review Board, per dwelling unit off public streets. Parking must be confined to interior of the Unit and not on public right of way. Keeping cars from parking on the street overnight has a two fold effect: it keeps the streets clear for emergency vehicles and it helps the Security Staff to monitor for criminal activity. The HOA is enforcing the covenants when we send letters to persons who park on the street overnight.

- Broken curb or sidewalk? Call the City of Montgomery at 241-2880. They are very responsive to requests.
- New landscaping was installed on the Wynlakes Boulevard Island at Lakeridge Dr.
- Remember parking on the lawn is a City of Montgomery code violation which can carry a \$50.00 fine.
- Golf carts can be fun vehicles when driven and ridden properly. Be safe this summer and make sure your golf cart is "street legal." Street legal means license tags, appropriate lighting, and a legal licensed driver 16 years of age or older.
- If you live on the side of Wynlakes Blvd with the maple trees, please remember to water them regularly. If they are completely dead, please call the HOA office.
- Trees can create a great canopy over the sidewalks if left untrimmed. However, branches which are hanging over the sidewalks can be dangerous to your neighbors. Please trim them as often as possible to avoid impeding walkers and children riding bikes. Also they can block the sensor on the street light that tells it when to cut on and off.
- Solicitors: We try very hard to control soliciting in Wynlakes but the ordinance says if the street is public, they

have a business license , and there is not a "NO SOLIC-ITING" sign on the house or yard, they have the right to solicit. Please continue to call Security if you see anyone soliciting. We will ask them to leave. B&B ad

Junk, Litter, Trash: Sanitation problem or Housing Code problem?

The first question we will explore is: "When is junk, litter and trash a Sanitation issue and when is it a Housing Code issue?"

Sanitation picks up "trash" once each week. Trash is considered to be yard waste, grass clippings, leaves and small limbs. Small limbs are defined as being no longer than 4 feet and no bigger than 8 inches in diameter.

All grass and pine straw must be placed and kept in a container at all times. The container must be 30 gallons or less and tied at the top.

Leaves may be loose only from October 1st through April 15th. However, the City seeks to have residents place leaves in a bag all year round as factors such as wind and rain drive up the cost of service and restricts the City's ability to perform their job.

Sanitation will gladly pick up other items if a bulk pickup is scheduled. The bulk pickup will be \$10.00 - \$70.00 per truck load. Appliances will be \$10.00 per unit.

Otherwise, the junk, litter, or trash will be considered a Housing Code issue. Some examples of litter are: uncontainerized manmade waste materials including paper, plastic, garbage, bottles or cans. Examples of junk are: vehicle parts, rubber tires, dilapidated furniture, building material or appliances. These nuisance violations can be reported by calling the City's 311 customer service center.

THE "OVER" PUBLIC STREETS OF WYNLAKES

If you have <u>never</u> had to dodge a runner/jogger in Wynlakes, add a donation to your favorite charity. Numerous residents have brought this dangerous situation to my attention. It is a serious problem for those of us who frequently drive in the early morning or at twilight-we encounter the runners almost daily. Many of the runners are not dressed to be easily seen. My fear is that this is an "accident" waiting to happen. Just imagine how terrible it would be for a new driver, who would unintentionally "swipe" one of the runners and then have to live with a lifetime of guilt. Of particular concern to me, and what prompted this letter, is when I came upon runners pushing babies in strollers in the street. Remember that under the Al Code Acts 1980, Section 32-5A-215 these actions are illegal. Wynlakes has sidewalks that can be used by our runners and joggers in safety for both themselves and for their driving neighbors. Property owners will receive one letter on the first violation of debris placed curbside after the normal pickup day. All violations that occur within six months and subsequent to the first violation will result in a letter informing the homeowner
